

**Borough Council Re-Organization Meeting

**Name Bank Depository** - A motion was made by Mr. Daly and seconded by Miss Meyer to name First Citizens Community Bank as the Borough's Bank Depository. **Under the question:** Mrs. Dekar explained that First Citizens Community Bank has been the Borough's bank depository since 2006. **Roll Call: Mr. Bentley, Mr. Daly, Mrs. Dekar, Miss Meyer, and Mr. Wayman; YES.**
